The Committee shall be responsible for:

- i) Framing and implementing guidelines for conducting and monitoring research conducted within the college for faculty and students.
- ii) Approving research proposal submitted by the students and faculty.
- iii) Provide competent and timely review of all research proposals submitted to ensure the scientific validity of the studies within the standard norms of national and international guidelines. In addition it will ensure that all research it approves will also conform to applicable central, state and local laws and regulations.
- iv) Reviewing and evaluating research proposal for onward submission to University/ Institutional Ethical Committee or University/Institutional Animal Ethical Committee, if required.
- v) Reviewing and evaluating research proposal for intramural and extramural funding for onward submission to University Research Committee. After obtaining approval from University/ Institutional Ethical Committee or University/Institutional Animal Ethical Committee, as the case may be.
- vi) Suggest strategies to improve research proposal that fall short of expected scientific & ethical standards.
- vii) Refuse approval of research proposal that do not meet the expected scientific & ethical standards.
- viii) Work towards facilitating the collaborative and multidisciplinary nature of scientific research, maintaining the integrity of the research process, detecting and declaring all conflicts of interest in research conduct and research review, reporting research misconduct, and ensuring research is driven by relevance to local needs and the interest of patient care and scientific advancement over personal motives.
- ix) To assist in the development and the education of a research community responsive to local health care requirements.
- x) To assess all publications by faculty or post graduates for fulfilling the authorship guidelines laid down by Research Committee of the constituent academic unit, for evaluation of any conflict of interest, authenticity of hospital and patient's data, and recommendation for cash incentives.
- xi) The Research committee will review the scientific validity of all research proposals/projects in a wide range of medical, biomedical, social, education, behavior fields, all clinical trials and interdisciplinary areas. It would scrutinize the scientific validity, accurate representation of Institutional work, etc. of all papers for publication and poster or platform presentation to be done at local, national or international level by the faculty members or post/undergraduate students.



- xii) The Research Committee will also look into the appropriate authorship in publication from the University and conflict of interest. The committee will review and has to approve all publications (in peer reviewed journals) and presentation at conferences before submission. This committee is recommending body for cash awards and incentives on research projects and publications conducted in the constituent academic unit(s). This list is to be forwarded to University/Institutional Research Committee for its sanctioning.
- xiii) Oversee and guide faculty for research publication.
- xiv) General supervision and monitoring of research work in various departments of concerned academic unit(s).

This letter supersedes earlier constituted Research Committee(s) at the respective college / school level.
