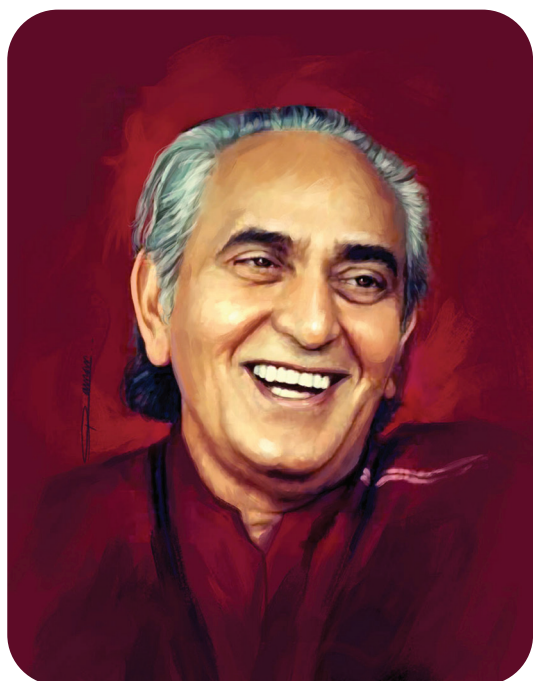

## About Program

The General Duty Assistant (GDA) is a 6-month programme running under Swami Rama Himalayan University with a focus on competency-based learning to equip candidates to work as health care assistants in both hospital and home care environments.

The key responsibilities of the GDAs are to provide daily routine care to patients and look after their comfort, safety and basic needs. Throughout this course, candidates will acquire essential skills in handling patients and delivering bedside basic care. The course consists of classroom teaching, demonstration, and practical experience in a clinical setting. GDAs will collaborate closely with registered nurses and work under their direct supervision.

**Programme Duration:** 1000 Hrs. spread over 6 (six) months / (24 weeks)

**Seats Available:** 30 (Thirty)

### Eligibility Criteria

Candidate must have passed 10+2 or equivalent examination with any stream.

Age Limit: 18 to 30 years (Candidate shall be medically fit)

## Submission of Application and Payment of Fee

Interested candidates can apply online through the university website: [www.srhu.edu.in](http://www.srhu.edu.in)

The last date for submission of application forms is 30<sup>th</sup> May 2025.

### For online submission

- Candidates must register themselves via the link provided on the university website before submitting the application.
- The candidates must submit the General Duty Assistant application from their email IDs and mobile numbers only.
- Download the information brochure and read it carefully to understand eligibility criteria and other requirements for submission of the application form.

Once the applicant has filled out the online application form, she/he will be redirected to the online payment page for submission of the requisite fee. The Application fee is Rs. 500/- with transaction charges as applicable.

### Mode of Fees Payment

The fee can be deposited through RTGS/NEFT/Net Banking directly to University Bank Account No. 33082676422, IFSC: SBIN0010580, State Bank of India, HIHT, Jolly Grant, Dehradun, Branch Code: 10580.

The candidates are required to submit a proof of RTGS/NEFT/Net Banking payment in the office of the Medical Superintendent, Swami Rama Himalayan University immediately after payment is done.

## Instructions for Counseling / Admission

- i. The admission to the General Duty Assistant shall be made purely on the basis of the merit list prepared as per the marks obtained in 12th examination; in case of two/more candidates securing equal marks a candidate older in age shall get preference.
- ii. The date for counselling/allotment of seats shall be intimated by the Swami Rama Himalayan University to the eligible candidates.
- iii. At the time of counselling/allotment of seats for General Duty Assistant, the candidate shall bring the following documents in original along with one set of self-attested photocopy of the same:

High School (10 <sup>th</sup> Class) or equivalent examination's mark sheet
High School (10 <sup>th</sup> Class) or equivalent examination's Certificate as proof of date of birth
Mark sheet of Intermediate or qualifying examination (12 <sup>th</sup> Class) from a recognized board
Pass certificate of Intermediate or qualifying examination (12 <sup>th</sup> Class) from a recognized board
Aadhar Card
Two recent passport size colored photographs
